SOURCES PROVIDE MORE INFORMATION ON LAUREN BOEBERT'S ABORTION, PAID ESCORT CAREER, AND DRUG USE

Today the American Muckrakers PAC, Inc., released additional information provided to us by seven of our sources. All are from Garfield County, Colorado, and know Lauren Boebert well.

The following is a statement from David B. Wheeler, President of American Muckrakers PAC, Inc:

“For personal, legal, and safety reasons – including recent threats and acts of intimidation by known Boebert supporters – at this time a number of our sources are not comfortable with having their identities revealed. American Muckrakers PAC, however, is in possession of the names, addresses, phone numbers, and email addresses of these sources, and have met in person with two of them.

Based upon the lies Lauren Boebert has spread in the media and elsewhere over the weekend, they have all agreed to provide information on a Jane Doe/John Doe basis.

We realize that the press and others may not be satisfied with the Jane Doe/John Doe nature of the information. But their safety is of paramount importance.

Boebert has announced plans to sue anyone connected with our efforts to fire her, so why would they subject themselves to unneeded harassment? All the Jane Doe/John Doe sources will appear voluntarily to be deposed and to appear in court if legal proceedings commence.

Two of our sources are currently in hiding at a friend's home in another county. This was deemed necessary after an unannounced visit by three individuals which led them to feel that they were being threatened. Another source was confronted by an unidentified man at her gym who told her he knew where she lived. She has discussed the encounter with the Glenwood Springs Police Department; she is taking the threats very seriously.

We are asking anyone with additional information about the people intimidating our sources to please contact us or law enforcement.”

Introductory Note from American Muckrakers

Below are individuals that have provided information to American Muckrakers PAC, Inc., regarding Lauren Boebert.

As you may be aware, Rep. Boebert has vowed to sue American Muckrakers, their supporters, their officers, and their donors* both civilly and criminally**.

In addition, three of the individuals have been visited by people trying to intimidate them. Their safety is paramount.

We certainly respect that and understand that anonymous identities may not satisfy the press or others. Regardless, we believe Colorado voters are smart enough and know enough about Boebert to make their own decisions about whether this information resonates or not.

* Individuals or organizations can't sue other parties criminally.

** Donors have zero civil or criminal liability for donations and never will. Boebert is simply trying to intimidate donors and potential donors to stop them from making donations to American Muckrakers.

Sources of Information about Lauren Boebert

Below is alleged information related to Boebert. All of these individuals have reviewed this information with the exception of John Doe 1, Mr. Bishop, and Ms. Hooper. John Doe 1, Mr. Bishop, and Ms. Hooper's statements are summaries based upon recorded phone conversations and text messages with representatives of American Muckrakers.

Every person listed below, except Mr. Bishop and Ms. Hooper, has agreed that they will be voluntarily deposed and testify in court for any legal matters that arise as a result of our work in attempting to hold Boebert accountable.

Jane Doe 1: This person works in the healthcare field in Colorado. This person was asked by Boebert to drive her to Planned Parenthood of Glenwood Springs, Colorado, in the fall of 2005, where Boebert had an abortion.

Jane Doe 1 escorted Boebert inside the Planned Parenthood clinic and then waited in the car until Boebert emerged. She then helped Boebert back into the car, got her home, and took care of her for the rest of the day. She was introduced to meth by Boebert and did meth and other drugs with Boebert over several years. She has been through rehab and has been drug-free and employed since then. Boebert also told her about another abortion Boebert had in Grand Junction, Colorado. Finally, Boebert and this person bought the bejeweled, high heeled shoes together in the picture circulating on the Internet at a store in Denver called Hot Topic in the Lone Tree Mall in Denver.

Jane Doe 2: This person is a relative of Jane Doe 1. She has seen the SugarDaddyMeet.com website profile of Boebert. In addition, she learned of the Boebert abortion when Jane Doe 1 directly told her the details of the Planned Parenthood Clinic appointment contemporaneously. She is also friends with Jane Doe 3 and shared that information contemporaneously with her via personal conversations and text messages.

Jane Doe 3: This person is a Colorado small businesswoman. She was at a fundraising event in Aspen, Colorado, in February 2019, where Senator Ted Cruz, a Koch family member, and Lauren Boebert were also in attendance. Jane Doe 3's company was a supplier for the event at a private home near Aspen. She observed Boebert being introduced to Senator Cruz by a Koch family member. Based upon the conversation she overheard between Boebert and Cruz this was their first meeting.

Jane Doe 3 has screenshots of Boebert's profile on the SugarDaddyMeet.com website. She was at a dinner at a private home with friends in 2014 when one person showed her the profile picture of Boebert. The entire group at the dinner viewed the profile and burst out in laughter as they had all heard about the profile but never seen it until that night. She subsequently took screenshots of the profile pictures.

Jane Doe 4: Jane Doe 4 has first-hand knowledge, texts, and other information related to Boebert's drug and alcohol use.

John Doe 1: This person has known Jayson Boebert for more than 20 years. He formerly worked with Jayson Boebert on an oil rig site. He and his wife saw Lauren and Jayson Boebert using meth many times at the Boebert home.

Tori Hooper: Tori is the former sister-in-law of Boebert. She worked at Shooters Grill in Rifle, Colorado, for several years. Hooper has direct knowledge of, and has been recorded speaking about, the 2019 ATV accident in which Boebert was the driver. In addition, she has knowledge of Boebert's alcohol use and patterns related to partial payment or late payment of wages. She also has knowledge of Boebert's relationships with employees.

Mike Bishop: Mr. Bishop has known Boebert since she was born. He has direct knowledge and possesses documents related to the sale of her airplane as the broker. Boebert reportedly sold the airplane she owned for \$1.00 on October 18, 2018. However, the price the plane sold for according to a text from Bishop to Lauren Boebert was "you got the price you wanted". We assume this was substantially more than \$1.00.
